Move-ups to the next higher level will be offered. Move-ups for the first test of the weekend should be emailed to the trial secretary at least three days in advance. Move-ups during the weekend should be coordinated with the trial secretary at least 30 minutes before the start of the higher-level test.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs six months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or an AKC Canine Partners listing number. Approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the Fetch test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

ENTRY FEES

Both pre-entries and day-of entries will be accepted for these tests.

Pre-entries: \$25 per test per dog Day-of entries: \$30 per test per dog

WAIT LIST

Little Rock Dog Training Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 20 entries per test will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to October 17, 2025. No entries may be withdrawn with a refund after closing on October 17, 2025. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

TEST SITE

There will be a secretary table for day-of entry registration and information. Exhibitors must also check in for each level at the designated times at the check-in station where the running order will be maintained.

Dogs may be crated in vehicles or limited crating space is available inside the Little Rock Dog Training Club building. This building is not air conditioned. Dogs will be crated out of view of the Fetch test area.

Exhibitors are responsible for cleaning up after their dogs. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the test site. In such case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

COLLARS, LEASHES, AND HARNESSES

Dogs must wear a collar. Dogs may wear slip collars, buckle collars, or martingales in AKC Fetch tests. They may not wear prong collars, e-collars, head collars, muzzles, or body harnesses. Leashes should be 4-6' long and should be made of fabric, leather, or biothane.

REFUNDS

As per the AKC Fetch Judges Guide, when a Fetch test is cancelled, the club will contact any pre-registered entrants. The club will communicate the change to any potential day-of entrants by the method which they originally advertised.

If the club cancels the Fetch test, pre-registered entrants will be given a refund for their entry fees. The cancellation should be reported to fetchinfo@akc.org

No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical conditions are not eligible for a refund. Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial, but earlier notification is preferred, if possible.

RINGSIDE

Judges are not required to wait for dogs. The owner/handler of each dog is solely responsible for having it ready at the test area when it is to be judged. Little Rock Dog Training Club has no responsibility to provide service through a public address system, stewards, or runners for the purpose of calling or locating dogs that are not brought into the test site when required.

Exhibitors MUST check in at the designated area EACH day they are entered.

Exhibitors should follow their veterinarian's recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local or state health requirements, for example, proof of rabies vaccination.
